*CIP, Inc* will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics/lighting, interference from guests, etc.

*CIP, Inc* reserves the right to terminate this contract at any time for any reasonable cause, e.g. accident or ill health. In this event all monies paid will be refunded in full.

Any liability on the part of *CIP, Inc* will be limited to the amount of monies paid.
